## Non accessible content

The content listed below is non-accessible for the following reasons.

### Non-compliance with the accessibility regulations:

- Some images do not have a text alternative, so people using a screen reader cannot access the information. This fails WCAG (Web Content Accessibility Guidelines) 2.1 success criterion 1.1.1 (non-text content).
- Some content fails to meet the contrast requirements listed by the accessibility guidelines. This fails WCAG 2.1 success criterion 1.4.6 (Contrast Enhanced). This fails WCAG 2.1 success criterion 1.4.3 (Contrast Minimum) and 1.4.6 (Contrast Enhanced).
- Some content is not OCR'd and made accessible. This fails WCAG 2.1 success criterion 1.4.5 (Images of Text) and 1.4.9 (Images of Text ( No Exception)).
