This accessibility statement applies to the website www.heritagequay.org.

This website is run by the University of Huddersfield archives service called Heritage Quay. We want as many people as possible to be able to use this website. For example, that means you should be able to:

- change colours, contrast levels and fonts
- zoom in up to 300% without the text spilling off the screen
- navigate most of the website using just a keyboard
- navigate most of the website using speech recognition software

We know some parts of this website are not fully accessible:

- whilst the Immersive Read and Read Aloud function screen readers in Edge Chromium are compatible with the website, any browser that requires an additional download (like Claro) to screen read the website will not work
- the map on our Visit page is constrained to the image bar so you can only see a small section of a map and it can't be expanded to full page.

- our audio oral histories and video content do not have closed captions or transcripts available on the website
- images visible in the online catalogue do not have alternative text tagged information

We plan to add text alternatives for all images by December 2020. When we publish new content we'll make sure our use of images meets accessibility standards.

This statement was prepared on 19th June 2020. It was last reviewed on 28th October 2020.

This website was last tested on 12th December 2019. The test was carried out by The University of Huddersfield. We used <u>Accessibility Insights for Web</u> and <u>WebAim Wave</u>.

Additional accessibility testing was carried out on the 28th October 2020. The following pages were tested:

The page were tested with Edge Chromium's screen reader, <u>Immersive Reader</u>, and an overlay app called <u>ColorVeil</u>. This was testing for colour contrast and code tags compatible with readers.
