Non-accessible content

The content listed below is non-accessible for the following reasons.

Non-compliance with the accessibility regulations

Content

Some images do not contain an alternative text attribute. This does not meet WCAG 2.1 success criterion 1.1.1 (Non-text content).

Headings, labels, text and descriptions have been identified as missing. 'Bold' and 'I' tags have been used to format text. This does not meet WCAG 2.1 success criterion 1.3.1 (Info and relationships).

There are instances where links are identified only by colour. This does not meet WCAG 2.1 success criterion 1.4.1 (Use of colour).

There are instances where the colour contrast is insufficient. This does not meet WCAG 2.1 success criterion 1.4.3 (Contrast (Minimum)).

There is no option to skip repeated content. This does not meet WCAG 2.1 success criterion 2.4.1 (Bypass blocks).

There are cases where link text is used for multiple different destinations and image links are missing alternative text. These do not meet WCAG 2.1 success criterion 2.4.4 (Link purpose (In context)).

Input field has no description included. This does not meet WCAG 2.1 success criterion 3.3.2 (Labels or instructions).

There are instances where an element ID is not unique. This does not meet WCAG 2.1 success criterion 4.1.1 (Parsing).

There are instances where some user interface components cannot be programmatically determined. This does not meet WCAG 2.1 success criterion 4.1.2 (Name, role, value).

Issues with PDFs and other documents

Many of our older PDFs and Word documents don't meet accessibility standards – for example, they may not be marked up so they're accessible to a screen reader. This doesn't meet WCAG 2.1 success criterion 4.1.2 (name, role value). Any new PDFs or Word documents we publish should meet accessibility standards.

Content that's not within scope of the accessibility regulations

Older PDFs and other documents

The accessibility regulations <u>don't require us to fix PDFs or other documents</u> <u>published before 23 September 2018</u> if they're not essential to providing our services.

Older podcasts

The accessibility regulations <u>don't require us to provide transcripts for podcasts</u> <u>published before 23 September 2020</u>. Though we will provide them for new podcasts, we won't provide them for podcasts published before September 2019.

What we're doing to improve accessibility

We are looking to correct these compliance issues at the earliest opportunity through development work on the site and we are improving our software development and user experience design processes so that they take account of accessibility requirements as early as possible.
